2010 TERMS AND CONDITIONS

PARTICIPANT CONTRACT

I have read this brochure and feel appropriately informed by Longacre Expeditions about the trip of my choice. I have also read this Enrollment Agreement, specifically Part 6 below, and will abide by these rules and regulations. I understand that at times I will be required to put my needs behind those of other individuals in the group and that forming cliques is destructive to the goals of the summer. I feel enthusiastic about the program, and if accepted, agree to participate with a positive attitude.

PARENT/GUARDIAN AGREEMENT

Permission is granted to Longacre Expeditions, Inc./ assigns to hospitalize/treat/order injections/anes-thesia/surgery for my child/ward. I further authorize Longacre Expeditions, Inc./assigns to provide routine health care and first aid as well as administer routine prescription drugs. My child may use bicycles, climbing/caving equipment, horses, kayaks or other equipment necessary to the program. My child may participate in any trips and activities organized by the Longacre Expeditions staff; may travel via public carrier, or in vehicles operated by Longacre Expeditions, Inc. Photographs/statements of/by/about my child may be used in promoting Longacre Expeditions or its related activities.

I understand that Longacre Expeditions, Inc. has an excellent safety record. I further understand and feel properly informed about the risks and dangers inherent in wilderness adventure, water sports, rock climbing, bicycle riding, kayaking, and other program activities. I have read and agree to all the terms, and agree to release Longacre Expeditions, Inc., its agents and guide services it contracts with, of any and all liability and responsibility for any loss/damage to property or personal injury incurred on this trip under the direction of Longacre Expeditions, Inc. in which my son/daughter/ward is participating.

I believe my child/ward is capable of handling all aspects of a Longacre program and that he/she is enthusiastic about participating. I have read and agree to all terms as stated in this Enrollment Agreement. This agreement may only be modified in writing and signed by all parties.

DETAILS

1. Enrollment Agreement

Please have both parent/guardian and participant sign the Enrollment Agreement and send it with a deposit of \$900, which is fully refundable if you are not accepted into the program or if the trip of your choice is already full. Please refer to the Payments, Refunds and Withdrawals section for more information regarding this deposit and other payments.

Enrollment Agreements are accepted on a rolling basis and subject to availability. In our application process, we seek to ensure that students are capable of and interested in meeting the physical and emotional demands of the program. Longacre Expeditions reserves the right to refuse and/or rescind acceptance to a student who we believe is unsuited for our programs for health, physical ability, or behavioral history reasons. Failure to fully disclose any information regarding the participant that results in inappropriate placement in a Longacre Expeditions program is cause for dismissal without refund.

2. Payments, Refunds, and Withdrawals

A deposit fee of \$900 must accompany your Enrollment Agreement, which is refundable in full if you are not accepted into the program or if the trip of your choice is already full. Visa, Mastercard, Discover, check or wire transfer may be used for this and all payments. Payments made by credit card are subject to a

3% processing fee. Upon acceptance into the program, 50% of this deposit becomes non-refundable; the remainder is refundable until March 1.

The tuition balance is due March 1. Participants enrolling after March 1 have 30 days from the receipt of their enrollment application (or the start date of their program, whichever is earlier) to submit the balance of their tuition. **A two percent late fee will be applied to the balance of tuition not paid by the deadline outlined above.** Because our costs are prepaid well in advance of the departure date and cannot be recovered by Longacre Expeditions, the applicant and his parents/legal guardian release their right to reverse or dispute all credit card charges made to Longacre Expeditions. For withdrawals with written notice that are received prior to March 1, applicants forfeit 50% of the \$900 deposit. The deposit becomes entirely non-refundable after March 1. For withdrawals between March 1 and April 1st the entire tuition less the deposit will be returned. For withdrawals not covered by our Tuition Refund Insurance, or if you have chosen not to take out our Tuition Refund Insurance, after April 1st the entire tuition will be forfeited.

Please understand that the seasonal nature of summer programming precludes the rebate of any tuition for late arrival, early withdrawal, or dismissal for cause. If you leave a trip voluntarily after it starts, there is no refund of tuition. If you are sent home from a trip for disciplinary reasons, there is no refund of tuition.

Longacre Expeditions is not responsible for costs incurred by a participant's family for a program that has been altered or changed. All tuitions are calculated based on current tariffs, fuel and energy costs, and currency exchange rates as of September 15. Longacre reserves the right to adjust our published tuition should there be any increase in these rates or costs.

3. Tuition Refund Insurance for Documented Medical Situations

We strongly suggest the purchase of our tuition refund insurance that covers documented medical situations. This insurance entitles you to a refund of tuition less deposit for withdrawal prior to the trip and a prorated portion of the tuition less deposit for incidents occurring during the trip if withdrawal is the result of a medical problem.

We also strongly recommend purchasing travel's insurance from a 3rd party, which reimburses you for airfare and other costs if you cancel or leave a program early.

4. Medical Information

Any disability arising during a Longacre Expeditions program must be examined and verified by a physician of Longacre Expeditions' choosing. The cost of medical services including transportation expenses and medication are the responsibility of the family.

5. Spring Packet

Each Spring we send participants a packet of information including but not limited to the following: a detailed list of required clothing and equipment, a catalog of items we offer for sale or rent as a convenience to families, a medical form to be completed by a doctor, a medical insurance information form, travel plans, and liability waivers required by some guide services with whom we contract. These forms need to be completed and returned within 14 days after receiving the packet. **Failure to return these vital documents means your child will not be allowed to participate in a Longacre program.**

6. Rules and Regulations

Safety is our primary concern. As a result of our outstanding staff and our strict safety policies, Longacre Expeditions has an excellent safety record. For the

safety and comfort of all participants, it is important that parents and students understand and agree to our policies. Students must obey safety rules as established by Longacre Expeditions and any guide services contracted by Longacre. Unsafe actions will not be tolerated. Helmets, lifejackets, seat belts and other safety equipment and footwear must be worn at all appropriate times. Students are not permitted to use/possess marijuana/other illegal drugs/alcohol/tobacco while under the supervision of Longacre Expeditions. Abusive, destructive, violent or unsafe behavior, excessive swearing, or theft will not be tolerated. Violation of these rules will result in dismissal without refund of tuition. The cost to transport the participant home will be borne by the parents. Participants are discouraged from bringing personal audio devices and other electronic devices.

7. Other Expenses

Families should be prepared to incur some other expenses associated with an expedition with Longacre. Upon receipt of the enrollment agreement, we send a list of required clothing and equipment for that specific trip. It is the responsibility of each family to make sure that the participant comes properly equipped with appropriate gear. For your convenience, we sell some of the items on the list in the Spring. On selected programs we also rent expedition backpacks. For certain international programs, participants are responsible for obtaining the necessary vaccinations and/or medication as spelled out in the Spring Packet. **Tuition does not include the cost of transportation to and from the course area.**

We recommend the purchase of our tuition refund insurance. We also recommend that kids come with a limited amount of spending money. Medical expenses are borne by the family's medical insurance.

8. Itineraries

It is our intention to follow our itineraries. Due to the nature of summer programming, we reserve the right to alter our itineraries due to unusual snow or water conditions, weather, other acts of God, acts of war or terrorism, or other causes. In all cases we will make every effort to substitute an activity or location with something comparable. If a trip must be cancelled for any reason, a prorated portion of the tuition will be returned.

9. Expectations

All Longacre Expeditions programs described in this brochure are well within the ability range of young people of average athletic ability who have a positive attitude and possess the desire to participate. Through our application process every attempt is made to be clear about the nature of and demands of the program. Ultimately, however, it is the responsibility of the parent/guardian to assess the appropriateness of these programs for their son/daughter. Participants who do not possess sufficient desire can become physically or emotionally drained and therefore unable to safely complete a program. In such case, Longacre Expeditions reserves the right to terminate the participation of said individual without refund.

10. Personal Property Insurance

Longacre Expeditions does not cover the theft, loss, or damage of personal property and equipment of trip participants. We suggest that parents confirm that their insurance coverage covers these losses.

11. Governance

In the unlikely event a question or dispute arises from this contract, both Longacre Expeditions and the participant, parent or guardian hereby agree that the said question or dispute will be settled within the state of Pennsylvania, the county of Perry, according to Pennsylvania Law.
